Full versions of accepted papers will be published in the CITPM conference proceedings. The proceedings will have an ISBN number. All papers that will successfully pass double-blind review process will be published in a printed book proceedings that will be send for indexing in Conference Proceedings Citation Index - Social Science & Humanities (The Thomson Reuters ISI Index), accessible at the Web of Science.
